- GSA Support and emergency bursaries: GSA Emergency fund we received 278 applications and approved 43. Support Bursary we had 1168 applications and 634 were approved. \$40,792.00 was given to graduate student who needed emergency support. We have less than \$15,000.00 but we can longer take any more applications for
